Attendance at a driver training school is not required for students who have obtained a learner's permit. age 19 and have held the learner's permit for at least **60** days.

### **Behind the Wheel**

A learner's Permit is required to take the class. Students **are required** to take fourteen course lessons. Seven behind the wheel instructed driving lessons, and seven course lessons of observation. **Each course lesson is 50-minute mandatory session and must be completed to assure understanding of taught course and be complying of certification process.**

What you need to bring to your first class:

1. Learner's Permit
2. Photography of you learner's Permit
3. Driver Education Certificate
4. Behind the Wheel Agreement filled out and signed by you and Parent/or guardian if student is under 18 years of age.

### **Terms & Conditions of Contract**

1. Brake Thru Driving School does not guarantee that any student will pass the state license examination, secure a license or be guaranteed employment upon completion of a course instruction.
2. All refunds must be requested in writing and will be at the sole discretion of Brake Thru Driving School. Any refunds given will be calculated on a course/session % completion basis and will incur a **\$35.00** administration fee.
3. Missed instruction will be made up within seven days unless a medical excuse is presented.
4. If a student is absent in excess of 10 hours, the student's enrollment will be terminated and completion of the course(s) will be the discretion of Brake Thru Driving School.
5. Students will be required to complete all 14 periods of Behind-the-Wheel instruction.
6. A No-Show fine of \$35 will be charged of the school is not given 12 hours of advance notice of BTW session cancellation.
7. Payment in full is required prior to scheduling any driving appointments
8. A \$35 fee will be charged for returned checks.
9. A full hour of absence is charged to the student when he/she does not attend the full 50 minutes of BTW & Observation.
10. Should the school or assigned instructor experience an emergency we will perform our part of this contract within a reasonable period of time.
11. The student driver must possess a valid Virginia learner's permit or drivers license to be eligible for any of our driving services.

### **One-On-One Training**
